REQUEST FOR BIDS – WASTEWATER TREATMENT PLANT HOT WATER HEATER AND BOILER

The Town of Pittsford is requesting bids for removal of their old boiler and hot water heater, and replacing with a new gas boiler and gas on demand hot water heater at the wastewater treatment plant located at 305 Arch Street, Pittsford VT 05763. Eligible contractors are asked to submit a lump sum bid along with proof of insurance on or before May 28, 2026 at 11:00am. For a site visit, please contact Shawn Hendee at 802-483-6297, between the hours of 6 am to 3 pm. Monday through Thursday and 6am-10am on Friday.

Contractor is responsible for supplying all labor, materials, and equipment. All work and materials will be guaranteed for one (1) year.

Any and all contractors planning to bid are encouraged but not required to set up a meeting to review the project on or before April 27, 2026. **All bids are due at 11:00am on May 28, 2026.**

Proof of Insurance Coverage:

Contractor shall furnish the Town with Certification of Insurance including Worker's Compensation Insurance, as required by applicable State law, with the bid. Contractor shall ensure that all sub-contractors carry Worker's Compensation Insurance for all work performed by them.
